# Potential Health Conditions Or Risk Identified

The table below lists some of the health conditions Clinical Labs testing can identify. Based on the test results, the employee may have a high likelihood of having or developing the disease/condition in the future. By making changes to diet, exercise and lifestyle factors, employees may reduce risk and improve their health. Resulting improvement in employee health often leads to an increase in workplace performance.

Heart Health	Lipid Studies (Cholesterol and Triglycerides), ECG
Diabetes Check	Blood Glucose HbA1c
Liver Health	Liver Function Tests, Hepatitis A, B or C Serology
Thyroid Health	Thyroid Function Tests
Anaemia Check	Haemoglobin, Ferritin, Iron Studies
Kidney Health	Urea, Electrolytes, Creatinine
Drug and Alcohol Abuse	Urine Drug and Alcohol Testing, COT (Cotinine)
Bowel (Lower Colon) Health	Occult Blood Test
